Standard Terms and Conditions

- Permit applicant must be 21 years old.
- Payment is required in full in order to reserve a pool operated by the Walpole Recreation Department.
- Holds on pool rentals will not be made without complete payment. If complete payment isn't received prior to the pool reservation, the reservation will be voided.
- The Recreation Department does not cancel pool reservations due to inclement weather. If the applicant chooses to reschedule their reservation due to weather, the Recreation Department will make every reasonable effort to find an alternative date for the reservation.
- If the applicant chooses to cancel their reservation, partial refunds may be issued upon request, however a 20% administrative fee of the overall rental cost and the security deposit will be deducted from the fee.
- All use must comply with the occupancy levels and be compatible with the pool uses and surrounding property.
- There will be no smoking in the building or alcohol allowed at the pools.
- Food or drink allowed with prior approval.
- Other arrangements or unusual requests may be established and negotiated separately by the Recreation Director as determined in the best interest of the Recreation Department. Arrangements must be in general compliance with the Policy Statement, and be agreed in writing.

Payment is required in full in order to reserve a pool operated by the Walpole Recreation Department. Holds on pool rentals will not be made without complete payment. If complete payment isn't received prior to the pool reservation, the reservation will be voided. The Recreation Department does not cancel pool reservations due to inclement weather.
